

## Nurse Practitioner Alliance of Alabama – 2019 Awards

The *Nurse Practitioner Alliance of Alabama 2019 Awards Ceremony* is planned for October 4-5, 2019 during Annual Meeting/luncheon at the 13<sup>th</sup> Annual Conference held at the Wynfrey Hotel in Birmingham, Alabama. This is an event you will not want to miss!

Awards will serve as a testament to the individuals in Alabama who are making a difference in the lives of their patients and students, and as recognition for those delivering and advocating for outstanding patient care. The NPAA Awards provide an opportunity to give recognition to individual health care providers, educators or advocates, the in-the-trenches team members and the leaders who inspire, motivate and empower others around them to make a difference in the lives of those for whom they provide care.

### Eligibility Criteria:

- Nominees **must be a member or student member** of the Nurse Practitioner Alliance of Alabama
- (NP Awards) Nominees must have practiced in Alabama for one year preceding the nomination
- (NP Faculty Award) Nominees must have been a full time faculty for one year prior to nomination
- (NP Student Award) Nominees must have completed three semesters of NP coursework
- Nominees **must be registered for the conference with plans to attend to receive the award**

### How to Nominate

Professionals may nominate an outstanding peer, mentor, supervisor or themselves in one or more of the listed categories. Nominations must to be submitted electronically ([NPAAawards@gmail.com](mailto:NPAAawards@gmail.com)) no later than **MONDAY, August 16, 2019 at 5:00 p.m. CT** with the following information:

- Letter of Support- in 500 words or less, provide objective data that conveys the nominee's abilities and/or achievements in the 4 categories listed below.
  1. Overall achievements will be considered, as well as single, one-time innovative programs/efforts that demonstrate outstanding results.
  2. Specific programs or efforts to improve health and health care as a member of the health care team, educator or advocate for advanced nursing practice.
  3. Leadership qualities (ability to manage and mentor internally, externally and interprofessionally).
  4. Other relevant qualifications such as creativity, critical thinking, and successful financial management within a health care organization or similar outcomes.

### Judging/Selection Process

An independent panel of judges will review each submission from the documentation submitted. **Award winners MUST be registered and attend the event to qualify for receipt of the award.** Before you submit your nomination, please make sure your nominee is planning to attend the conference.
